Mare must be specifically booked by name. Booking is valid only to mare and owner named, and may not be transferred without the express consent of Bonley Farm. All mares must be registered with the USTA or Standardbred Canada, and DNA-typed or blood typed. In order for a mare to be bred to a Bonley Farm stallion, this contract must be completed, signed and returned to Bonley Farm.

Visiting Mares: Bonley Farm reserves the right to test mares for infection at the expense of the owner. Bonley and/or Cool Winds Farm will exercise judgment consistent with recognized standards in the care and supervision of mare and/or foal, and will arrange veterinary and farrier services, as necessary. Bonley Farm's veterinarian will examine the mare for breeding condition and will administer medical care as deemed necessary for reproductive efficiency and health of the mare and/or foal. All veterinarian and farrier expenses will be paid by Mare Owner upon being billed by Bonley or Cool Winds Farm. Neither Bonley Farm, Cool Winds Farm, or their members, agents or employees, shall be liable for any injury, disability or death suffered by any horse, from any cause whatsoever, while in the custody and care of Bonley Farm or Cool Winds Farm, and the undersigned owner specifically assents to such condition, and waives all and every claim for any damage resulting from any injury, disability or death.

Service and Breeding Fees: Service Fees for Cheyenne Rei and Ghee's House will be billed by Bonley Farm, and are due and payable when mare has live foal, or changes ownership, whichever comes first. A live foal is defined as: A foal that is able to stand up and nurse. **Important Service Fee Information-**Regardless of reason for eligibility, all Bonley Farm discounts are Prompt Payment Discounts offered on service fees paid by thirty (30) days after mare has a live foal, and only on accounts that are current at the time the service fee is due.

Bonley Farm and Cool Winds Farm bills are issued monthly, and are payable on receipt. All accounts must be settled before mare and/or foal is removed from Bonley or Cool Winds Farm. Non-resident Mare Owner acknowledges the value and convenience of transported semen, the labor, skill and expense of semen collection, preparation, packaging and transportation, and agrees to pay for these goods and services upon receipt of a monthly bill from Bonley or Cool Winds Farm. If any charges due and owing in a given month are not paid within 30 days, the owner hereby authorizes Bonley Farm to add to said owner's account, a service charge of .015 per month which is 18% annually. Mare Owner acknowledges Bonley Farm's right to a lien for the care of the mare, for the value of the labor and skill applied, for any materials or costs incurred for the keeping of the mare and/or foal, and acknowledges Bonley Farm's right to retain possession of the mare until such time as the charges are paid, pursuant to Michigan Compiled Law 570.185. It is further understood that Bonley Farm shall have an additional lien for any costs and expenses incurred by the Farm after the lien was initially placed on the mare which shall be computed and ascertained upon the trial, or assessment of damages, and shall be included in any judgment against Mare Owner. Mare Owner agrees to pay all costs and actual attorney fees incurred by Bonley Farm in its effort to collect said charges. The owner of any mare shipped to Bonley Farm or bred with semen from a Bonley Farm stallion has accepted the terms and conditions of this contract.
